Current Region Secretaries or the National NMRA Secretary may provide certification when the appointed officer is not available or when many positions will require several signatures.
- 3. Submit a completed Statement of Qualifications (SOQ) itemizing evidence of the completion of the above requirements. In case of exceptionally outstanding service, the Chair of a committee or the appointing officer, in the case of a Committee Chair, may initiate the SOQ for a member whom he or she knows to have met the requirements. However, the member must sign the "Member's Statement and Agreement".
